Timber Utilisation Plan

VicForests has prepared a Timber Utilisation Plan (TUP) to allow for timber harvesting of areas not subject to the Allocation Order 2013 as amended. Management of timber harvesting in areas outside the Allocation Order 2013 as amended was transferred from the Department of Environment and Primary Industries (DEPI) to VicForests in 2014. The TUP prepared by VicForests is equivalent to the Wood Utilisation Plan (WUP) previously prepared by DEPI.

Specified conditions

VicForests recognises that all planning and operations of VicForests must comply with all relevant laws including, but not limited to:

- i. the Forests Act 1958 (Vic);
- ii. the Conservation, Forests and Land Act 1987 (Vic);
- iii. the Flora and Fauna Guarantee Act 1988 (Vic);
- iv. the Road Management Act 2004 (Vic; and
- v. the Traditional Owner Settlement Act 2010 (Vic); and

Proposed Timber Utilisation Plan Amendment - November 2019

The Timber Utilisation Plan aligns with long-term resource sustainability as outlined in the document "Review of Commercial Forestry Management in Western Victoria", DEPI, 2013.

The objective of the Proposed TUP amendment documents is to provide stakeholders details of the location and approximate timing of proposed timber harvesting operations and associated management activities.

The Proposed TUP amendment does not signify any significant change in approach to harvesting, but rather seeks to:

- Update planning documentation which has not been renewed for some years;
- Replace a number of coupes which have been harvested with new areas;
- Remove coupes from the plan which are no longer required or have been incorporated into the Timber Release Plan;
- Meet ongoing operational requirements and business commitments.

As this is an amendment to the current TUP, this Schedule only shows proposed changes to the current approved Timber Utilisation Plan.

1. Glossary

Coupe – A contiguous area of forest of variable size, shape and orientations from which timber is harvested or in which other forest management activities may be undertaken.

Coupe Address – A unique 12-digit reference number that indicates the location of an individual coupe.

Gross Area/ Coupe Boundary - The area within which operations will be conducted. It is represented spatially by the 'proposed coupe boundary' that is mapped within CENGEA Forest Planner and approved for inclusion on a Timber Utilisation Plan. This area may include sections which are not expected to be harvested (e.g. to align the boundary to a geographical feature such as a road).

Silviculture System – Describes the method that will be used to regenerate (and hence to harvest) the coupe.

Timber Utilisation Plan / TUP – A Timber Utilisation Plan is a list of areas and corresponding maps, outlining where timber harvesting and regeneration works are authorised to be completed by VicForests. Timber Utilisation Plans can fall within any Forest Management Area (FMA) but may not incorporate an area captured by the Allocation Order 2013 as amended.

Wood Utilisation Plan / WUP – A Wood Utilisation Plan is a list of areas and corresponding maps, outlining where timber harvesting and regeneration works are authorised to be completed as prepared by government departments (most recently, DEPI – the Department of Environment and Primary Industries). In addition to commercial operations, WUPs also included areas for domestic firewood collection and other forest works to be completed by the Department. Wood Utilisation Plans can fall within any Forest Management Area (FMA) but may not incorporate an area captured by the Allocation Order 2013 as amended.

2. Silviculture categories

Silvicultural treatments have been grouped into categories to allow the most appropriate treatment to be selected based on the forest type and on operational, regeneration and forest health requirements.

Use of a silviculture category with a higher number is permitted with operational approval.

Use of a silviculture category with a lower number requires the use of a formal approval process.

Category	Common forest structure	Silvicultural intent	Silvicultural systems may be selected from (or utilise a combination of) the following:
Category 1	Even-aged	Stand replacement	CFE – Clearfall extraction, STR – Seed tree, RRH – Regrowth retention harvesting, CFS – Clearfall salvage, SH1 – Shelterwood one.
Category 2	Multi-aged	Stand maintenance/ manipulation	THA – Thinning from above, THB – Thinning from below, STS – Standard single tree selection, GSE – Group/ gap selection or creation, UNE – Uneven-aged, SH2 – Shelterwood two.
Category 3	Specialty timbers	Removal of individual stems	STS – Low intensity single tree selection.
Category 4	Previously harvested/ fallen	Ground collection	FWF – Firewood - fallen, FPR – Fallen product recovery.
Category 10	No structure - forest cover has been removed from the site.	Reforestation. <i>Re-establishment of forest cover.</i>	REF – Reforestation.
Category 20	Low-intensity salvage operations	Low-intensity salvage operations. <i>Salvage of small areas/ individual trees (e.g. windthrown stems)</i>	SAL – Low intensity salvage, FWF – Firewood - fallen, FPR – Fallen product recovery.
Category 30	Removal of potentially hazardous trees	Removal of potentially hazardous trees. <i>In consultation with DELWP staff/ operations.</i>	HTR – Hazardous tree removal, FWF – Firewood - fallen, FPR – Fallen product recovery.

INVITATION FOR COMMENT ON PROPOSED CHANGES TO VICFORESTS' TIMBER RELEASE PLAN AND TIMBER UTILISATION PLAN

VicForests is seeking to amend its Timber Release Plan (TRP) and Timber Utilisation Plan (TUP).

VicForests has prepared its TRP and TUP in line with the Sustainable Forest Timber Act, as part of the approval process for all operations. The plans outline VicForests' proposed harvesting activities for the coming years. The proposed TRP and TUP are consistent with recent Government policy announcements regarding old growth protection, Immediate Protection Areas (IPA) and the Greater Glider Action Statement.

We plan to submit these amendments to our Board for approval following a public consultation process.

VicForests is conducting a public consultation process from 20 November to 12 December 2019 to ensure the community has an opportunity to provide comment on the proposed amendments.

In accordance with the timelines of the TRP and TUP process, we request any coupe specific comments by 12 December 2019, but welcome further engagement on broader land management issues throughout the year. The map and schedule of all VicForests' proposed TRP and TUP changes are attached for reference.

As part of this amendment process coupes are being added to the TRP and TUP to ensure we can meet our contractual commitments to customers, contractors and licensees, and have the necessary flexibility required to plan future harvesting operations.

Areas that have been harvested and successfully regenerated are being removed from the TRP and TUP along with a number of other unharvested areas as part of these amendments.

Thank you for your letter dated 20 November 2019 inviting comment on VicForests' proposed changes to the Timber Release Plan (TRP) and Timber Utilisation Plan (TUP).

- The *Sustainable Forests (Timber) Act 2004*, the *Forests Act 1958*, the *Conservation, Forests and Lands Act 1987*, the *Forests Act 1958*, the *Flora and Fauna Guarantee Act 1998*, the *Road Management Act 2004* and the *Traditional Owner Settlement Act 2010*;

- Codes of Practice including but not limited to, the *Code of Practice for Timber Production 2014* (the Code) and the *Code of Practice for Bushfire Management of Public Land 2012*;
- The Forest Management Zoning Scheme;
- The protection of large living trees greater than 2.5 metres in diameter;
- Any agreed actions related to the Victorian Forestry Plan, including commitments to immediately cease harvesting of old growth forest and within Immediate Protection Areas (IPAs); and
- The requirements of the Greater Glider Action Statement and other Action Statements made under the *Flora and Fauna Guarantee Act 1998*.

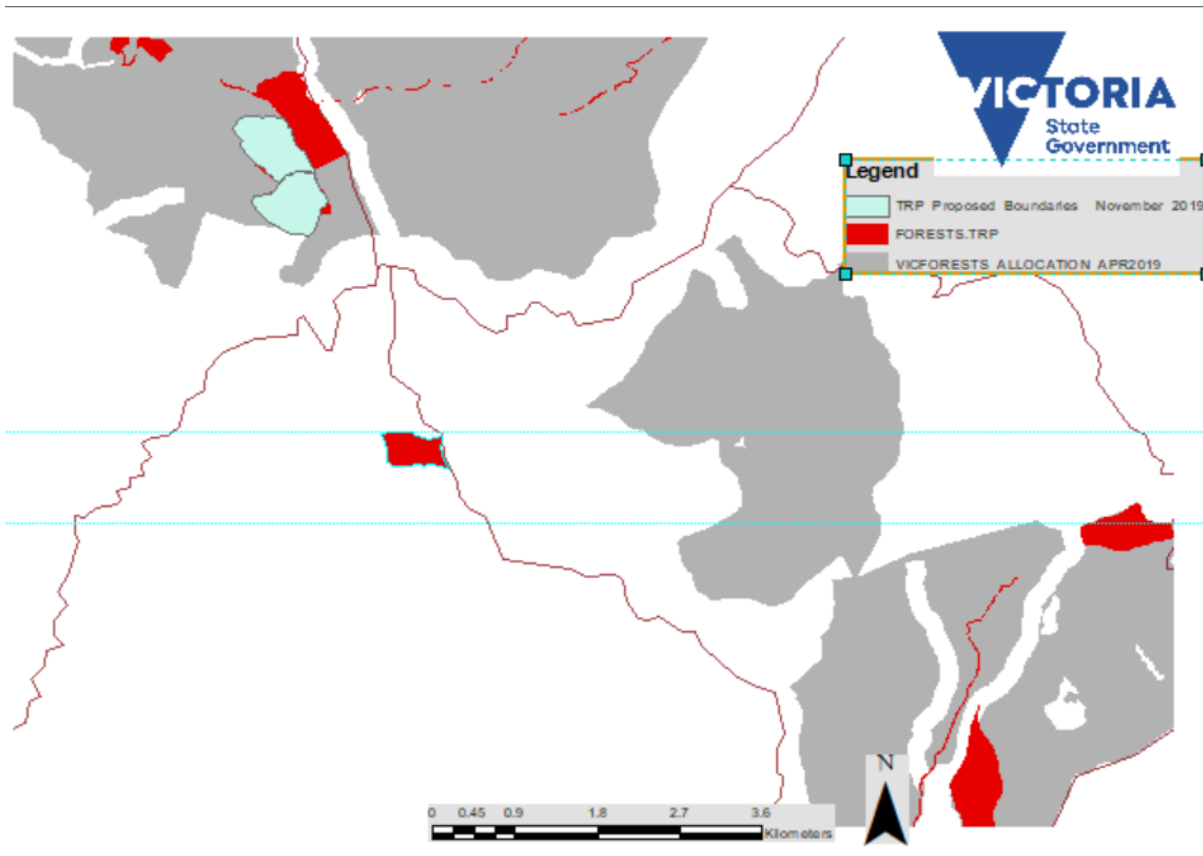

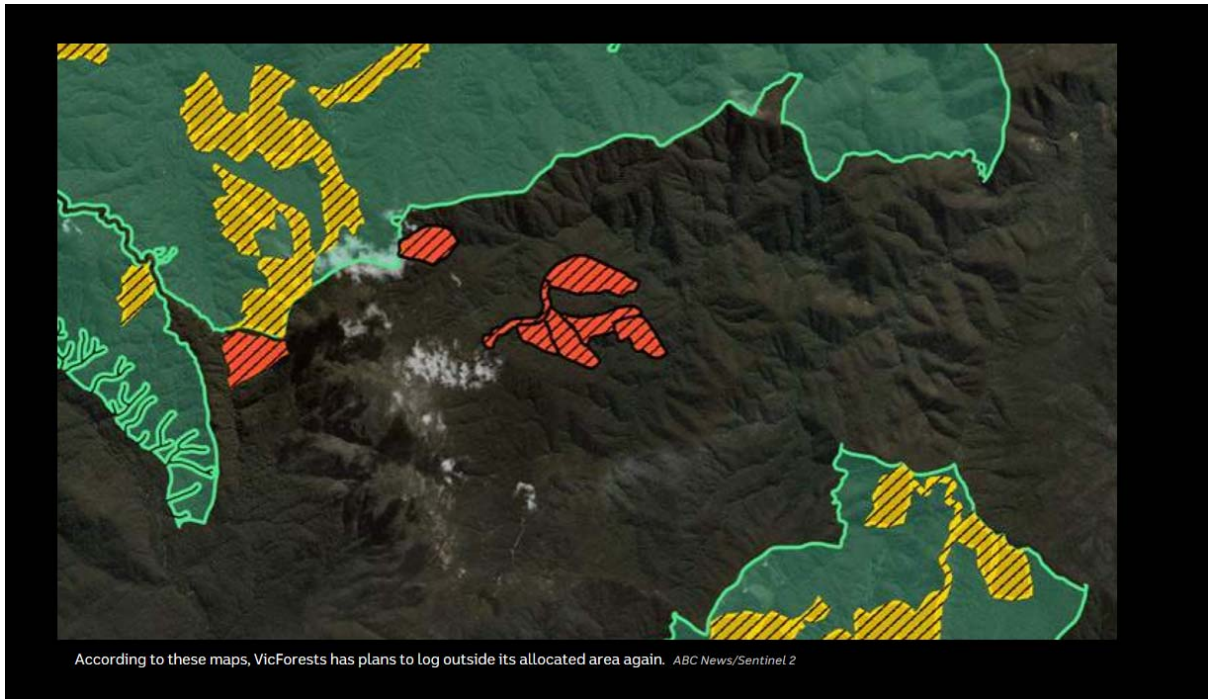
