

Timber Release Plan and Timber Utilisation Plan: December 2019

Recommendation

That the Board **approve** the change to VicForests' Timber Release Plan and Timber Utilisation Plan as proposed.

Issue:

Approval of VicForests' Timber Release Plan (TRP) and Timber Utilisation Plan Change: December 2019

Background:

TRP

In May 2019 an Operations review was undertaken

Management therefore seeks the Board's approval for a change to VicForests' Timber Release Plan, which proposes 717 coupe changes.

TUP

1. Timber Release Plan - Background

VicForests has prepared a Timber Release Plan (TRP) change as contemplated in Part 5 of the *Sustainable Forests (Timber) Act 2004 (Vic) (the Act)*.

S.37 of the Act requires VicForests to prepare a plan in respect of an area to which an Allocation Order applies for the purposes of:

- a. harvesting and selling, or harvesting or selling, timber resources; and
- b. undertaking associated management activities in relation to those timber resources.

S 43 of the Act allows for VicForests to change a timber release plan at any time, if the change is not inconsistent:

- a. with the allocation order to which the plan relates, including any conditions, limitation, matter or specification in the order; and
- b. any relevant Code of Practices relating to timber harvesting.

According to VicForests' Timber Release Plan - Process for Preparation and Approval Instruction, July 2017, Board approval is required for any changes to an existing Timber Release Plan.

VicForests is authorised to conduct timber harvesting operations (as defined in the Act) and associated management activities (as described in the attached TRP Schedules) in accordance with any TRP in relation to an area to which an Allocation Order made under s.13 of the Act applies.

2. Timber Utilisation Plan

3. Objectives

The objective of the TRP/TUP Change Documents is to set out the details of location, nature and approximate timing of timber harvesting operations and associated management activities.

VicForests updates its TRP/TUP to:

- Maintain a flexible 2-3 year rolling operation schedule (coupes that have been harvested in the past 12 months need to be replaced with new coupes for the future);

- Ensure that approved and new coupes are consistent with the Allocation Order and government policies
- Ensure that currently approved coupes are consistent with the recent changes by Department of Environment, Land, Water and Planning (DELWP) to the Forest Management Zones;
- Modify boundaries based on improved planning information gathered on existing approved TRP coupes;
- Improve access on existing TRP coupes;
- Remove unviable unharvested coupes from the TRP; and
- Remove regenerated coupes from the TRP.

4. Details of the Timber Release Plan and Timber Utilisation Plan Changes

This Timber Release Plan Change includes:

A schedule of changes that includes 717 coupes, *Attachment 1: VicForests Proposed TRP Change: December 2019*.

- 432 new coupes;
- 39 amended coupes;
- 13 new access requirements;
- 231 removals:
 - 186 coupes successfully regenerated
 - 46 unharvested coupes (unsuited or not required)
- 2 coupes to have an increase in harvesting intensity

This Timber Utilisation Plan Change includes:

- (a) Once the TRP has been gazetted - an interactive map and all related website information of the Timber Release Plan will be updated.,
- (b)

According to Section 7.1.1 of the Management Standards and Procedures for Timber Harvesting Operations in Victoria's State Forests 2014, where a coupe boundary shown on a TRP map is mapped to a geographic feature and the actual location of that geographic feature does not match the mapped location, VicForests may move the coupe boundary a maximum of 30m from the mapped boundary to align with the actual location of the intended boundary feature.

According to Sections 1.3 and 1.4 of the Management Standards and Procedures, where any coupe boundary overlaps an SPZ and the area is field verified as not being SPZ, a variation Exemption to the MSP's will be sought from DELWP prior to harvesting; otherwise, the area will be excluded from harvesting and associated operations.

The same applies when access works are required through an SPZ.

TRP coupes are mapped to natural features and may contain areas that are not covered by the Allocation Order spatial layer but are field verified as being available for harvesting. This may include incorrectly mapped SPZ boundaries, private property and Park boundaries and areas identified as non-eucalypt, in the various GIS mapping layers used for planning. If operations are planned in these areas the appropriate authorisations will be sought as above through a variation Exemption to the MSP's and a Forest Produce Licence.

Where access is sought through Park, with or without the requirement of roadwork improvements, consultations and authorisations will be sought with the relevant authority in order to gain permissions to haul and/ or undertake roadwork improvements.

Attachment 3 – summarises each coupe with unallocated area within.

This TRP change is to take effect in accordance with the terms of a notice to be published in the Victorian Government Gazette pursuant to s.43(6) of the Act.

5. Stakeholder Consultation

General Consultation

VicForests conducted a draft stakeholder consultation from 21 October to 21 November 2019 with Government agencies, DELWP and Department of Jobs, Precincts and Regions (DJPR).

Consistent with the Allocation Order requirements, VicForests conducted a formal stakeholder consultation 21 November 2019 to 12 December 2019. This included formal notification to Government agencies, DELWP, Parks Victoria, Melbourne Water and DJPR.

A mailout to approximately 2000 external stakeholders, including shires, customers contractors and staff, was delivered to publicise the commencement. Approximately 70 letters were posted across the state.

Stakeholders were also notified through advertising in 13 different local newspapers and via a media release which was widely reported.

The commencement was also publicised in the external publication *The View*, sent to stakeholders on 9 December.

An Open House event was held on 11 December in Traralgon, a location centrally located within the Eastern FMU. This drew several groups of stakeholders from a variety of locations: the north-east, west Gippsland and central Gippsland. The Open House was advertised via local Press and online in the week leading up to the event.

A total of 39 submissions with TRP/TUP comments or enquiries, including detailed responses were received.

VicForests has consulted with traditional owner groups.

Prominent stakeholder concerns included:

- Haulage Concerns (Blue Range Road, North East Region).
- General Support for Industry and Concerns on latest State Government announcement.
- Coupe/Area Specific:
 - Timbertop Catchment (North East Region) Request for Field Trip, Geelong Grammar
 - Campbells Creek Area (North East Region) Request for Field Trip, Camp Toolangi
 - Kinglake, harvesting in proximity to private property (Kinglake, North East Region)
 - Snobs Creek Catchment (North East Region)
 - Coupes: Boys Shelter, Lodge and Boys Camp (Noojee, West Gippsland Region) some local community concern around fire hazard
 - Concern over harvesting in the Portland area (Western Victoria Region)
- General dislike of Native forestry – unsustainable practices, harvesting of rainforest, impacts on fire intensity, climate change raised as some concerns.
- Timber usage (Western Vic)

All stakeholders were advised that their submissions were received. All submissions will have a formal consultation and/or feedback. This is work in progress.

To note, DELWP response on a broad level (not coupe specific) was received from the Office of the Conservation Regulator, Chief Conservation Regulator . In the response she noted concern that the TRP/TUP did not address the application of the draft version of the Old Growth field verification procedure and application of the Greater Glider Action Statement.

Local Government Briefings

Responses were received from 7 Shires regarding briefings and or field trips.

Latrobe and Wellington Shire were briefed and undertook a field trip on 12 December. East Gippsland Shire were briefed on 16 December. All three shires were very supportive of the Native Forest Timber Industry and raised a number of questions regarding the Government announcement and the impact that this will have upon their communities.

Aboriginal and Cultural Heritage Summary

VicForests notified traditional owner groups, with the Tangurung group putting in a submission. A meeting was conducted on 10 December with this group regarding TRP concerns and process and further consultation will continue.

Aboriginal Victoria was consulted and we are awaiting results of their site assessments within coupes and 500m radius of coupe boundaries, the results of which will be incorporated into our planning processes.

First Nations Legal and Research Services was informed about the TRP in relation to Native Title and we will continue with consultation.

6. Specified conditions

VicForests recognises that all planning and operations of VicForests must:

- (a) comply with all relevant laws including, but not limited to:
 - i. the *Forests Act 1958 (Vic)*;
 - ii. the *Conservation, Forests and Land Act 1987 (Vic)*;
 - iii. the *Flora and Fauna Guarantee Act 1988 (Vic)*;
 - iv. the *Road Management Act 2004 (Vic)*; and
 - v. the *Traditional Owner Settlement Act 2010 (Vic)*; and
- (b) comply with all conditions, requirements and limitations in the Allocation Order 2013 (as amended by the Allocation (Amendment) Order 2014 and the (pending) Allocation (Amendment) Order 2019. The TRP Allocation Order Compliance and Consistency Check is provided in *Attachment 5*.

PURPOSE:

To provide a summary of Consistency Checks completed on the December 2019 TRP and TUP Amendments.

BACKGROUND:

The Consistency Checks represent the final quality assurance steps to the TRP and TUP preparation process prior to VicForests Board Approval.

These are necessary to ensure the proposed amendments comply with relevant legislation and are consistent with VicForests Operating Procedures and Instructions.

CONSISTENCY CHECKS:

For the TUP See Table 1 for a summary of the checks undertaken and Table 2 for the resulting actions and ongoing requirements and Table 3 for detail of areas excluded from timber harvesting operations.

For the TRP See Table 4 for a summary of the checks undertaken and Table 5 for the resulting actions and ongoing requirements.

RECOMMENDATION:

As a result of the TRP and TUP Consistency Checks, it is recommended that the Proposed TRP and TUP Amendments 2019, consisting of the following changes, be approved on the basis that the required actions will be undertaken:

TRP:

- 432 new coupes;
- 39 amended coupes;
- 13 new access requirements;
- 231 removals:
 - 185 coupes successfully regenerated
 - 46 unharvested coupes
- 2 coupes to have an increase in harvesting intensity

TUP:

- 97 new coupes;
- 7 amended coupes;
- 31 coupe removals;
- 15 coupes to have an increase in harvesting intensity

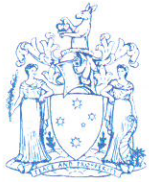

PROPOSED CHANGES TO THE TIMBER RELEASE PLAN 2019

Please see enclosed comment from the Office of the Conservation Regulator (the Conservation Regulator) on the proposed changes to the Timber Release Plan 2019 (the draft TRP)

I note that neither DELWP or the Conservation Regulator has a statutory role in the development or approval of a TRP

Timber Release Plan

Given the criticality of the TRP in supporting compliance with the Code of Practice for Timber Production 2014, the Conservation Regulator will assess any proposed new or amended TRP for consistency with the allocation order and advise VicForests on the outcome of this assessment to support compliance.

I note that within the draft TRP there are areas that are not included in the Allocation Order which are proposed to be available for Timber Harvesting or associated management activities.

VicForests must ensure that it has the appropriate statutory authorisation for all Timber Harvesting and associated management activities. I ask that VicForests ensures that the final TRP identifies those areas which are not allocated and clarifies with the Conservation Regulator how it is intended that Timber Harvesting and/or associated management activities will be authorised in those areas.

I note that the consultation webpage for the draft TRP highlights that VicForests will protect old growth forests and has agreed to apply the draft *Old growth forest field identification procedure* as published by the Conservation Regulator.

The draft TRP itself does not include any statement that clarifies VicForests' commitment to:

- implementing the relevant elements of the Victorian Forestry Plan (for example old growth forest protection and application of the requirements of the Greater Glider Action Statement),
- applying the draft and final versions of the *Old growth forest field identification procedure* as published by the Conservation Regulator, and
- working with the Conservation Regulator to support its Forest Protection Survey Program and its roles in monitoring and reporting on implementation of old growth forest and Greater Glider protections in accordance with the Victorian Forestry Plan.

I request that statements about VicForests' implementation of these matters be added to the revised TRP. This will clarify VicForests' commitment to these matters and help build community confidence that the Conservation Regulator can play an effective role in monitoring and reporting on implementation of the old growth forest and Greater Glider protections set out in the Victorian Forestry Plan.
